Investment Objective

The Cautious Income Portfolio targets an Income in of 3.5% by diversifying across a broad range of assets with differing return and volatility profiles.

The portfolio after Income is expected to maintain real value after inflation while minimising the possibility of the investment falling in value. The Cautious

Income portfolio investment value will fluctuate in the short term, but we would not expect significant falls in value over a sustained period.


Market Comment

In November the biggest news was the election of Donald Trump as President of the United States. The initial shock to financial markets, and for that matter most political pundits, was significant but the effect was short lived. By the end of the month equity markets globally were

near or beyond all-time highs although fixed income markets, justifiably hit by expectations of rising rates, and increasing government spending, fell sharply. During November we increased allocations to passive investments across the portfolios we manage, as active

strategies find it increasingly difficult to add value. As high valuations persist, we do not expect to shift back to higher active allocations until there is evidence a correction has started.
