## Investment Objective

The Aggressive portfolio seeks high capital growth over the long term. The portfolio aims to exceed long term equity returns at lower than equity levels of

volatility. The portfolio is expected to be exposed to market cycles and significant short-term fluctuations in value. While the portfolio may offer significant capital

growth opportunities there is also a high risk of capital loss over the short and medium term.

## Market Comment

August, as is usual, saw low volume and increased volatility for investors. That said and thanks to a strong rally in the last few days most assets, at least in Sterling terms, ended the month in positive territory as did all the Portfolios. A fall in sterling supported returns


for non-sterling assets and a moderation in interest rate expectations saw UK Gilts reverse recent losses and turn positive year to date. Outside the UK another terrorist attack, this time in Barcelona, and rising rhetoric between North Korea and the US clearly escalated geo-

political risk although any concerns appear to not have materially affected markets which continue to appear fully valued. Primarily due to this valuation the portfolios continue to hold a diversified, relatively defensive, allocation.
