Investment Objective

The Balanced Income Portfolio targets an income of 4.0% by diversifying across a broad range of assets with differing return and volatility profiles. After Income, the portfolio is expected

to maintain real value after inflation while minimising the possibility of the investment falling in value. The typical investor seeks consistent income from their investment but is able to accept a

moderate level of risk for the potential of higher income. They recognise that their capital is at risk and that its value may fluctuate.

Market Comment

Investor sentiment during November seemed never to recover from the lows of October, while investment markets to some degree did. After a positive final week most developed and emerging market equity indices recorded positive returns for the month. Fears over Brexit led to further losses in the UK but sterling weakness helped


further boost international returns. Fixed income, both government and corporate, saw modest losses as rates rose and credit spreads widened. Crypto currencies, which we have no exposure to, fell sharply but gold, which we do hold, held firm. The portfolio is expected to hold its modest underweight risk allocation into the

New Year unless something unexpected changes the economic outlook materially.
