Investment Objective

The Cautious Income Portfolio targets an Income of 3.5% by diversifying across a broad range of assets with differing return and volatility profiles.

The portfolio after Income is expected to maintain real value after inflation while minimising the possibility of the investment falling in value. The Cautious

Income portfolio investment value will fluctuate in the short term, but we would not expect significant falls in value over a sustained period.

Market Comment

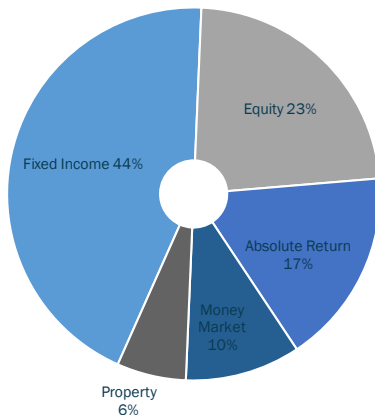
February was generally positive for investors, but markets remained volatile as the rebound experienced in January slowed. Domestic uncertainty regarding Brexit continued although the chances of an unplanned 'no-deal' exit from Europe appear diminished.

Similarly hopes of a positive resolution of the trade war between the US and China boosted confidence and increased valuations significantly. Concerns regarding valuation, and the short-term economic uncertainty led us to a tactical reduction of risk in the

portfolio at the end of the month. After a positive start to the year the portfolio starts March with a cautious allocation similar to the one held in September 2018.
