## Investment Objective

The Cautious Income Portfolio targets an Income of 3.5% by diversifying across a broad range of assets with differing return and volatility profiles.

The portfolio after Income is expected to maintain real value after inflation while minimising the possibility of the investment falling in value. The Cautious

Income portfolio investment value will fluctuate in the short term, but we would not expect significant falls in value over a sustained period.

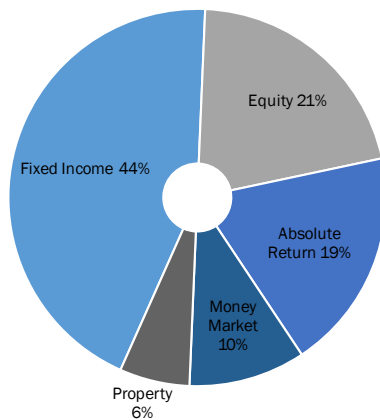
## Market Comment

June was a positive month for most asset classes with the portfolio setting a record high. Despite increasing risks over global growth and geo-politics, falling interest rate expectations boosted equity indices in most regions. The main driver to confidence was a series announcements from major

Central Banks, who seem prepared to lower rates further and increase extraordinary measures to maintain economic growth. Across the portfolio Anchor assets were positive but lagged strong equity Enhancer asset returns. Diversifier assets also gained, especially gold, as concern over the reliance

on Central Banks increased. The portfolio remains defensively positioned as we believe valuations are high. We expect opportunities to increase risk exposure at more attractive valuations in the coming months.

**"Diversifiers"**: selected for low correlation to traditional market equity and fixed income risk.

Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.
