Investment Objective

The Rivers ESG Balanced Portfolio targets long term capital growth in real terms and after fees. The portfolio invests only in solutions which pass strict criteria of Environmental, Social and Governance (ESG) requirements. The portfolio will be moderately exposed to global equity market cycles. The typical investor seeks capital growth from their investment and is able to accept a moderate level of risk for the potential of higher returns.

Market Comment

November saw further strong gains for Enhancer assets as US and Global equities set all time highs. Anchor assets struggled as benchmark interest rates rose causing government bond values to fall. Diversifiers, especially commodities and Gold, saw prices continue the fall from their late summer highs. Overall the portfolio gained setting its all-time highs but has struggled to keep up with benchmark returns in the last 3 months due to a defensive allocation. That said the portfolio remains above its annual return target and we believe equity indices, which are elevated, will offer more attractive opportunities to rebalance to a neutral stance in the coming months.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk.

Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

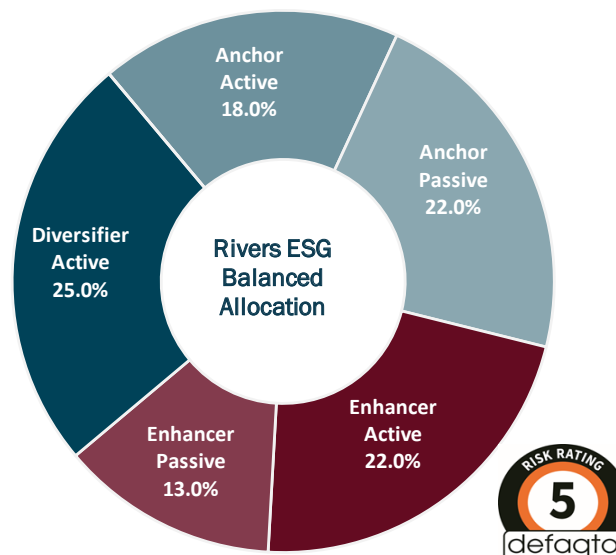

Notes:

- The performance data shown is indicative only. The performance is net of a 0.25%+VAT Rivers Capital Management fee and annualised since inception (March 31st 2017)
- Volatility is calculated as the annualised average weekly standard deviation of return since inception (March 31st 2017)
- The maximum loss is calculated as the total loss from the highest previous month end portfolio value. Intra month or daily data may exceed this.
