Investment Objective

The Rivers Adventurous Portfolio seeks capital growth, after fees, as its primary objective whilst maintaining a moderate constraint over overall short-term volatility. The portfolio aims to achieve its objective by diversifying across a broad range of global assets with differing return and volatility profiles. The portfolio will be exposed to global equity market cycles. Fluctuations in the value of the portfolio should be expected in order to achieve greater potential returns over the longer term.

Market Comment

The portfolio finished the year with positive performance in December and above target returns for 2020 overall. All asset classes were positive with Enhancers once again producing most of the gains. The approval of an effective vaccine against Covid-19 significantly boosted investor sentiment. Despite rising infection rates across Europe and in the US, the hope of a return to normality within months raised confidence. In the UK, the equity market, still below pre-pandemic levels, rallied strongly as news of the vaccine, and a comprehensive ongoing trade deal between the UK and EU became clear. The portfolio remains cautiously positioned as the outlook for 2021 looks more precarious than current equity valuations indicate.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk.

Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

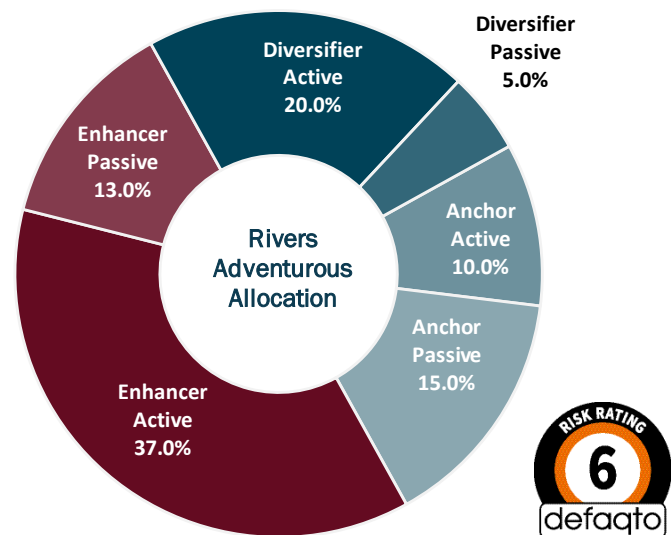

Notes:

- The performance data shown is indicative only. - Volatility is calculated as the annualised average weekly standard deviation of return since inception (June 30th 2016)
- The maximum loss is calculated as the total loss from the highest previous month end portfolio value. Intra month or daily data may exceed this.
