Investment Objective


The Rivers Balanced Income Portfolio targets an income of 4.0% by diversifying across a broad range of assets. The portfolio is expected to maintain real value, net of income, after inflation while minimising the possibility of the investment falling in value. The typical investor seeks consistent income from their investment but is able to accept a moderate level of risk for the potential of higher income. They recognise that their capital is at risk and that its value may fluctuate.

Market Comment

July saw all-time highs reached in US Equity indices again but overall Enhancers did not add much over the month. In fact Emerging markets struggled as the Chinese government placed considerable pressure on social media and technology. Possibly a sign of things to come in the developed world. Anchors, especially inflation-linked gilts, added the most value to the portfolio with Diversifiers, including Gold and real estate, also benefiting from continued inflation fears. Within Enhancers European Equity was the strongest performer with Japan faring worst. Our tactical position remains defensive as equity valuations generally remain high and we await better investment opportunities.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk.

Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:
