Investment Objective

The Rivers ESG Balanced Portfolio targets long term capital growth in real terms and after fees. The portfolio invests only in solutions which pass strict criteria of Environmental, Social and Governance (ESG) requirements. The portfolio will be moderately exposed to global equity market cycles. The typical investor seeks capital growth from their investment and is able to accept a moderate level of risk for the potential of higher returns.

Market Comment

In another strong month for Enhancer assets equities continued their relentless increase in value. Led again by the mega-cap US technology stocks investors remained confident record valuations are justified. US market indices set further all-time highs while European and Asian indices also advanced strongly. The portfolio, despite its defensive allocation, added value as the Anchor and Diversifier assets advanced led by Gold, Real Estate and Inflation-Linked Bonds. September is historically a challenging month for investors and with valuations at high levels we are happy to maintain the current allocation. We continue to expect opportunities later this year to add risk at more attractive valuations.

Rivers Asset Classification System:

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk.

Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

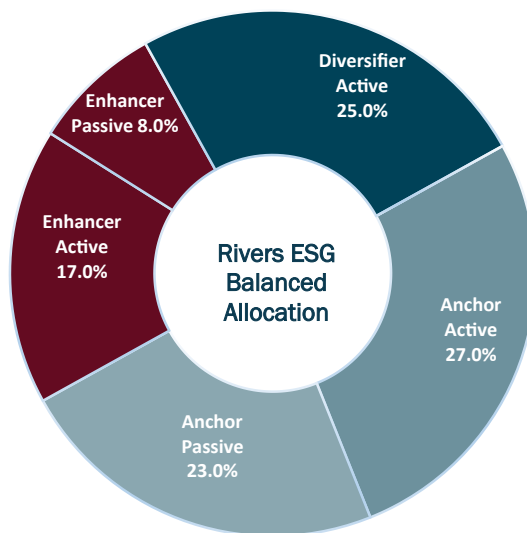
