Investment Objective

The Rivers ESG Balanced Portfolio targets long term capital growth in real terms and after fees. The portfolio invests only in solutions which pass strict criteria of Environmental, Social and Governance (ESG) requirements. The portfolio will be moderately exposed to global equity market cycles. The typical investor seeks capital growth from their investment and is able to accept a moderate level of risk for the potential of higher returns.

Market Comment

After an encouraging start, August proved to be a challenging month for many asset classes. The main cause was sharp increases in benchmark interest rates after Central Banks removed any doubt that fighting inflation was not their primary objective. This directly impacted both Government and Corporate Bond indices and indirectly caused a reversal in much of the Equity index growth seen during July. Within the portfolio losses were minimised through our emphasis on Value funds, within Enhancers, and Absolute Return funds, within Anchors. The Diversifier holdings performed well, especially Energy and Insurance. Any Emerging Market equity exposure and a devaluation of Sterling also helped. The portfolio remains underweight risk. Looking forward, with a lot of bad news already priced in, we are more optimistic, as investors, than we were at the start of the year.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

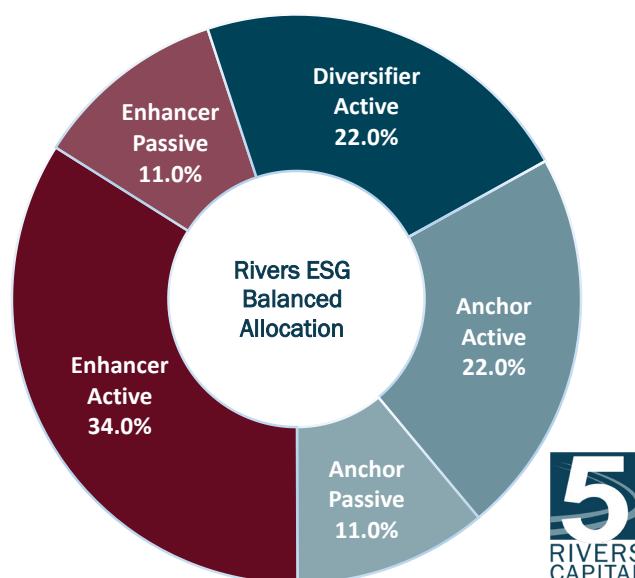
