Investment Objective

The Rivers ESG Balanced Portfolio targets long term capital growth in real terms and after fees. The portfolio invests only in solutions which pass strict criteria of Environmental, Social and Governance (ESG) requirements. The portfolio will be moderately exposed to global equity market cycles. The typical investor seeks capital growth from their investment and is able to accept a moderate level of risk for the potential of higher returns.

Market Comment

For nearly all asset classes September was, not for the first time this year, a difficult month for investors. Rising benchmark interest rates and fears of global recession pushed down both Anchor and Enhancer asset valuations simultaneously. Some Diversifiers, including Absolute Return funds and Gold (in Sterling terms), managed to add value but many, including Property and Commodities, were also negative. Within the portfolio relatively low direct exposure to Gilts, an overweight to Absolute Return funds and an underweight to the US tech sector provided some protection but there were few places to hide. Looking forward we expect to rebalance the portfolio during October. While the outlook from an economic perspective is not positive valuations are much lower. Some sectors remain expensive but the opportunity for tactical reallocation has improved significantly.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

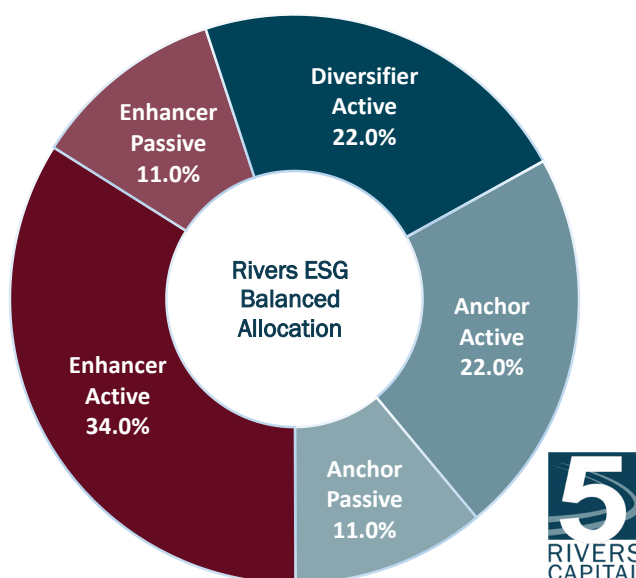
