Investment Objective

The Rivers Cautious Portfolio targets modest long term returns above inflation, and after fees, at controlled volatility levels. The portfolio aims to achieve its objective by diversifying across a broad range of assets with moderate return and lower volatility profiles. The portfolio may be somewhat exposed to global equity and interest rate market cycles. The typical investor seeks modest capital growth but must accept that the portfolio's investment value may fluctuate in the short term.

Market Comment

During February much of the investor enthusiasm seen during January waned. The narrative of falling inflation and a possible interest rate reversal was challenged. While some equities, mainly in Europe and the UK, saw gains the Global benchmark was down overall. Economic indicators remained robust and expectations of recession in the UK, and US, decreased. Within Anchors the increased allocation to money market funds protected the portfolio from rising longer term rates. Within Enhancers the best performing region was the UK and Europe while US, Japanese and Emerging Markets all struggled. Diversifiers overall also lost some value with Gold, Energy and Real Assets down over the month. The portfolio remains modestly underweight risk reflecting our objective of protecting capital but continuing to add opportunity from tactical adjustment.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

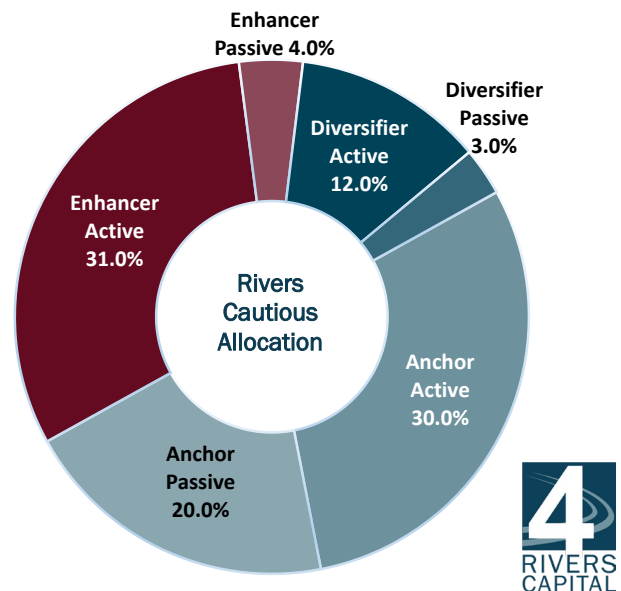
