Investment Objective

The Rivers Adventurous Portfolio seeks capital growth, after fees, as its primary objective whilst maintaining a moderate constraint over overall short-term volatility. The portfolio aims to achieve its objective by diversifying across a broad range of global assets with differing return and volatility profiles. The portfolio will be exposed to global equity market cycles. Fluctuations in the value of the portfolio should be expected in order to achieve greater potential returns over the longer term.

Market Comment

The portfolio value fell modestly during August. Considering only money market and some Diversifier asset classes were positive the losses were well contained. Enhancers struggled as earnings remained subdued and the concerns around the Chinese economy grew. The material losses were mainly concentrated in sectors and regions either not held, or underweight within the portfolio but the portfolio was still moderately affected. Overall nearly all developed and emerging market equity indices were down for the month. Within Diversifiers, the Commodity, Thematic and Macro allocations all added value . The Enhanced Cash allocation remains positive. Looking forward, the underweight risk allocation continues to be appropriate. We expect markets to be challenged over the coming months as the economic impact from tightening credit increases and inflation remains above target.

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.


"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.
