# **Balanced Income** Portfolio 30<sup>th</sup> September 2023

## **Investment Objective**

The Rivers Balanced Income Portfolio targets an income of 4.0% by diversifying across a broad range of assets. The portfolio is expected to maintain real value, net of income, after inflation while minimising the possibility of the investment falling in value. The typical investor seeks consistent income from their investment but is able to accept a moderate level of risk for the potential of higher income. They recognise that their capital is at risk and that its value may fluctuate.

## **Market Comment**

The portfolio value fell slightly during September and finished down over the third quarter. With bond yields rising to levels not seen since before the financial crisis and widespread global equity losses this was a positive outcome. Positive returns for the month came from money markets, selective equity holdings and some diversifiers. The short duration position within Anchors provided protection from increases in benchmark interest rates. Within Enhancers the UK provided positive returns as value out performed growth by the biggest margin so far this year. The message from the Bank of England, and other central banks, that interest rates may go higher and will be held high for at least a year saw investor sentiment fall sharply. Within Diversifiers precious metals and real assets struggled but commodities and insurance added value. We continue to expect markets to be challenged over the coming month but expect the opportunity to reallocate risk at more attractive valuations before vear end.

### **Rivers Asset Classification System:**

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

#### Notes:

- 1. The performance data shown is indicative only. 
