

Cautious Portfolio

31st August 2024



Investment Objective

The Rivers Cautious Portfolio targets modest long term returns above inflation, and after fees, at controlled volatility levels. The portfolio aims to achieve its objective by diversifying across a broad range of assets with moderate return and lower volatility profiles. The portfolio may be somewhat exposed to global equity and interest rate market cycles. The typical investor seeks modest capital growth but must accept that the portfolio's investment value may fluctuate in the short term.

Market Comment

After a spike in volatility in early August, which mainly impacted Enhancer exposure, the remainder of the month saw a strong recovery. Overall, the portfolio finished the month in slightly negative territory. The volatility was caused by concerns about recession in the US. This prompted changes in benchmark interest rates and a fall in the US dollar. Initial fears subsided as expectations of rate cuts offset concerns and economic indicators remained positive. Diversifiers were varied with Gold and Insurance positive although we saw losses within Energy, especially the Uranium allocation. Uranium producers have struggled in the short term but with demand continuing to rise and supply falling, the outlook is positive. In August the portfolio was rebalanced with changes primarily within the Diversifier allocation. The portfolio remains underweight risk as high valuations and geo-political risks remain concerning.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

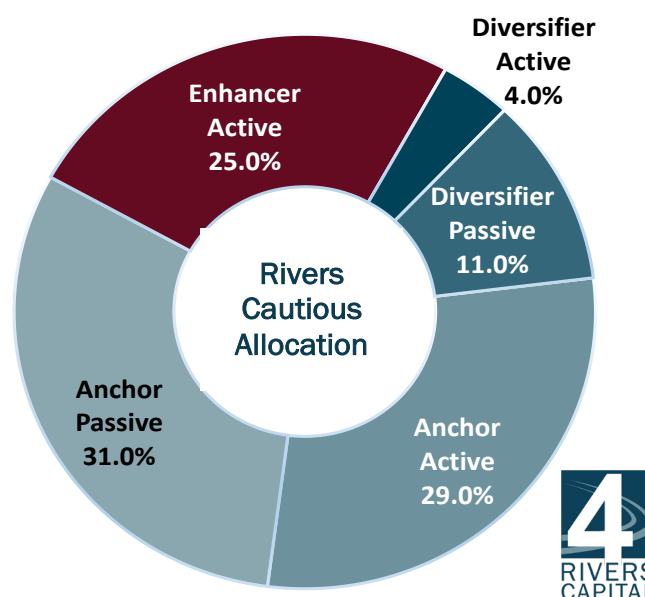
