Investment Objective

The Rivers Adventurous Portfolio seeks capital growth, after fees, as its primary objective whilst maintaining a moderate constraint over overall short-term volatility. The portfolio aims to achieve its objective by diversifying across a broad range of global assets with differing return and volatility profiles. The portfolio will be exposed to global equity market cycles. Fluctuations in the value of the portfolio should be expected in order to achieve greater potential returns over the longer term.

Market Comment

Volatility continued during September. Despite a recovery led by US stocks, global developed markets ended the month slightly lower, although a strong rally in Emerging Market equities, led by Chinese stimulus, ensured 'Enhancers' added value overall. 'Anchors' saw little change, as while Central Bank interest rates were cut, changes in longer term benchmark rates were modest. 'Diversifiers' added value as strong gains in Gold and Commodity prices offset falling energy prices and the value of producers. Similarly, gains in the UK Property allocation offset losses in the Macro and Insurance themes. With geo-political risk escalating, particularly in the Middle East, and equity valuations remaining high we maintain the view that a tactical underweight risk allocation is appropriate. After the US Presidential Election and when outcomes are seasonally more positive, we will review this allocation for year end.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

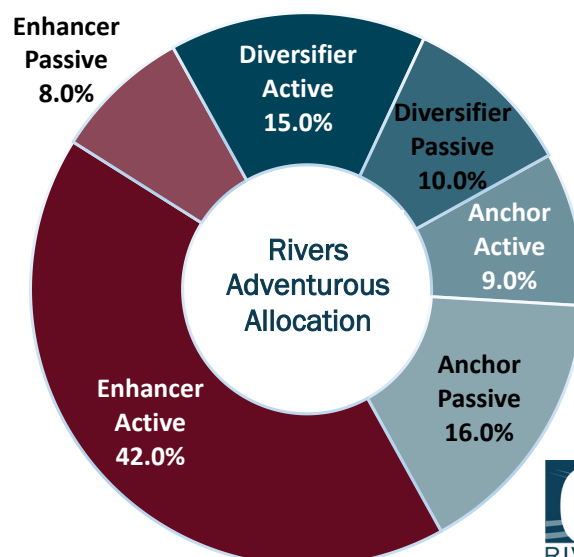
