Investment Objective

The Rivers ESG Balanced Portfolio targets long term capital growth in real terms and after fees. The portfolio invests only in solutions which pass strict criteria of Environmental, Social and Governance (ESG) requirements. The portfolio will be moderately exposed to global equity market cycles. The typical investor seeks capital growth from their investment and is able to accept a moderate level of risk for the potential of higher returns.

Market Comment

Asset class returns varied during October and the portfolio finished slightly lower for the month. With the UK Budget at the end of the month and US Election imminent, investors appeared nervous and without any clear direction. For 'Anchors', rising benchmark yields contributed to losses for any longer duration positions although this was offset by money market and low risk absolute return allocations. Within 'Enhancers', most regional allocations lost value. The exception was US equities which, led by technology, continued to add value and offset losses from other regions. 'Diversifier' returns were even more differentiated with the portfolio's strongest returns coming from any Gold and Commodity allocation but the biggest losses from Real Estate allocation. With the US election too close to call, volatility is expected to continue, and the portfolio remains tactically underweight risk.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

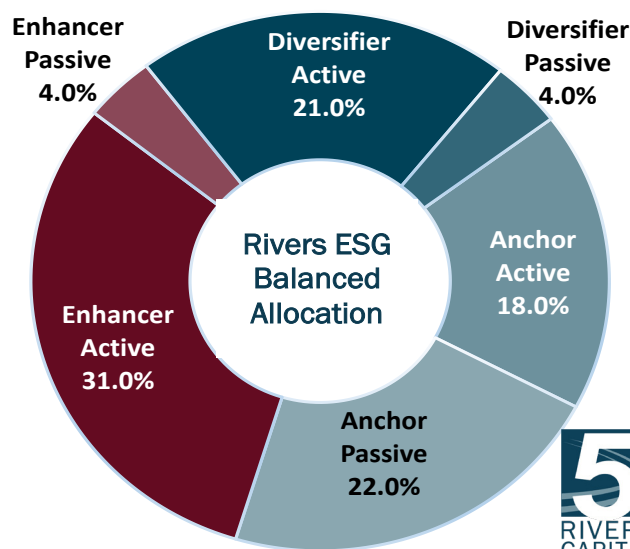
