

Rivers Aggressive Risk Portfolio



30th June 2025

Investment Objective

The Rivers Aggressive Portfolio seeks high capital growth after fees over the long term. The portfolio aims to exceed long term equity market returns at lower levels of volatility. The portfolio will be significantly exposed to global equity market cycles and material short-term fluctuations in value should be expected. While the portfolio may offer capital growth opportunities there is also a high risk of capital loss over the short and medium term.

Market Comment

Markets continued to recover during June, with many reaching all-time highs. Over the quarter, returns were modest, masking losses following President Trump's 'Liberation Day' on April 2nd and the subsequent strong recovery. Portfolio returns were boosted by increasing risk exposure on April 8th, resulting in a positive first half of 2025. During June the top contribution came from the Enhancer (equity) allocation with all positions, except Japan, up for the month and all up for the quarter. The Anchor allocation added value for both month and quarter. Diversifiers were mixed: Gold Miners, Real Estate, and Infrastructure posted positive quarterly returns, while Energy had a strong June despite a challenging quarter overall. The Uranium allocation was the top performer for both the month and the quarter. Looking ahead, we plan to secure profits and reduce risk during July.

Rivers Asset Classification System:

"Anchors": investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

"Enhancers": selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

"Diversifiers": selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

Notes:

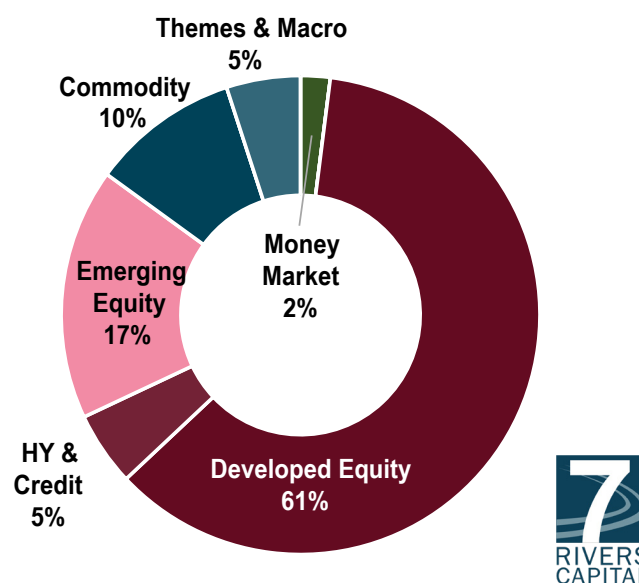
