

# Rivers Cautious Income Portfolio



31<sup>st</sup> January 2026

## Investment Objective

The Rivers Cautious Income Portfolio targets income of 3.5% by diversifying across a broad range of assets with differing return and volatility profiles. The portfolio is expected to maintain real value, net of income, after inflation while minimising the possibility of the investment falling in value. The portfolio may be somewhat exposed to global equity and interest rate market cycles. The portfolio's investment value will fluctuate in the short term, but we would not expect significant falls in value over a sustained period.

## Market Comment

2026 began with strong momentum, as nearly all markets posted positive returns in January despite rising geopolitical risks and concerns over debt and valuations. For the portfolio, all allocations were positive for the month. The Enhancer allocation added the most value, led by Emerging Markets, Global Equity and the UK. The Diversifier allocation was led by BNY Real Return and strong returns from infrastructure. The Anchor allocation rounded out the month with positive returns, led by the Absolute Return fund. Looking forward, we will be completing a rebalance in February but expect to maintain the overall risk level given continued uncertainty.

### Rivers Asset Classification System:

**"Anchors"**: investments selected for low market correlation, low risk and capital preservation core characteristics. Significant allocation in low risk portfolios.

**"Enhancers"**: selected to increase portfolio long term return but exposed to equity risk. Allocation likely to increase with risk tolerance as returns become more volatile.

**"Diversifiers"**: selected for low correlation to traditional market equity and fixed income risk. Diversifiers are essential for efficiency in all but the lowest and highest risk portfolios.

### Notes:

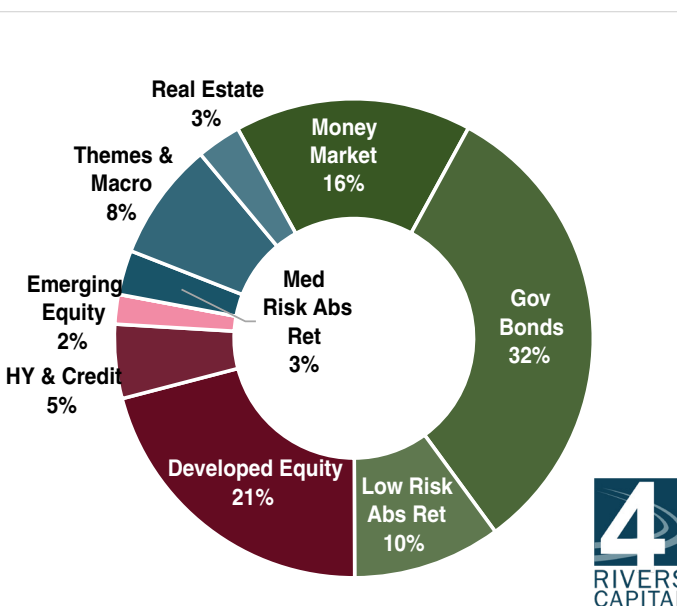
